TEXTILE AND APPAREL SAFETY AND TESTING

This course provides occupational knowledge on product safety and testing requirements that applies to raw material and finished garment in the fashion industry. This includes specific rules and regulations governed by the importing countries like USA and European communities not limited to testing and safety regulations. With this knowledge, it will reduce duplication in product quality testing and provide upfront information for raw material selection, to facilitate design changes to comply to importing countries regulations and eliminates misinterpretation so that the individual can make better decisions in materials management and improves communication.

PERFORMANCE OUTCOMES

- Determine the raw material and finished product safety requirements based on the importing regulations of the importing country
- Determine the basic objectives and principles for the material and product testing for the textile and apparel industry according to international test procedures
- Select appropriate tests and safety requirements for selected material and product to be tested and prepare test specimen according to technical manual
- Conduct tests according to established industry or international test procedures or send to approved laboratory according to the product safety regulations of the importing country
- Evaluate test specimens and test report results and make corrective / preventive actions
- Make recommendations and disposal actions
